

# Out with the Old, In with the New CPAP Trade-in Program

2. Customer must complete the trade-in form (below) and generate a proof of purchase (printed receipt).
3. Trade in devices from the following manufacturers will be accepted: DeVilbiss, Fisher & Paykel, Phillips-Respironics, ResMed and Transcend (Somnetics).
4. Customer must ship their approved trade-in CPAP device and power cord with the **completed trade-in form** and **proof of purchase** in the box, to:

Distributors and dealers may not participate in this offer. Limit One (1) rebate per qualifying Z1 CPAP or Z1 Auto CPAP device purchase and per traded in CPAP device.
